I understand and agree that released parties may not be held liable in any way for any occurrence with this Taekwondo tournament that may result in injury, death, or other damages to me or my family, heirs, or assigns, and in consideration for my allowing my child to participate in the tournament, I personally assume all risks in connection with said participation.
